Prior to submitting your completed Application Form to Licensing Services, please ensure you have:

 A full written submission outlining why you require the written approval for exemption. This must be completed by the applicant or business representative. The submission must also include:

- Premise and building details, including floor plan.
- Storage facility details.
- Outline operation procedures in place to ensure safe storage and handling of firearms and ammunition.
- Details of the driver and persons who will have access to the consigned goods. These details must be provided on a  **Nominated Person Application Form** and attached to your application.
- Details of any other security measures implemented for the storage and handling of firearms and ammunition.

 Included a completed Form 22 Storage Statement, with full colour quality photographs of any storage cabinet or storage container that will be used to store firearms or ammunition during transportation.

Note: If Transportation of firearms is required you will also need to apply for a Commercial Carrier Exemption.
