## General Information

- Temporary Permits are issued for a month or part there of, a fee applies (refer to website for fee) and can be paid by sending in a cheque or money order made payable to the 'Commissioner of Police' and posted to Licensing Services, Locked Bag 9, East Perth WA 6892 OR by credit card over the phone. Once payment has been received, the temporary permit will be posted out to the recipient with a receipt for the amount paid.
- Temporary Permits that are required to convey a firearm, or possess only do not incur a fee.
- Temporary Permits are issued **up to 3 Months ONLY** - and are only issued twice per year.
- Interstate Group Permits do not incur a fee.
- Part A, (pages 1 and 2) **MUST** be fully completed in order to process this application. Complete the Temporary Permit (Section 17) box or the Interstate Group Permit (Section 17A) box, not both. The Temporary Permit (Section 17) relates to an individual applicant applying for a permit. The Interstate Group Permit (Section 17A) relates to permits applied for by a representative of a group, club, body or organisation on the behalf of the organisation.
- Part B, (page 3) Details of Firearm/s and Ammunition must be completed for each firearm or ammunition type you wish to possess and/or use. Duplicate the page if you wish to seek a permit for more than 4 firearms or ammunition types.
- Individual applicants are not required to complete Part C. This only relates to Interstate Group Permit (Section 17A), when clubs and other groups are traveling together.
- Interstate and overseas applicants must include a copy of their Firearms Licence, club memberships and property owner permission letters where applicable.
- Temporary Permits relating to (First time imports) B709 Importation Permit must include the pre-arranged pickup date given to them by Australian Customs, and include full Registered Firearm Dealer details of where the firearm will be delivered to for storage pending licensing.
